C	Licence to trade as a mobile trader, e.g. mobile shops, ice cream vans, hand carts, etc.	£100.00	N/A

Note:

- Full time licences may be granted for a maximum period of 3 years from the date on which the licence is granted (terminating on 31 March of the third year of the licence)
- The fee of £100.00 covers the cost of the application and remains the same whether the licence is for 1 year or 3 years.
- However, all charges payable for the duration of the licence are payable on application.
