(3) **I/We understand** that the licence will not be granted if the premises do not comply with the requirements of the Act and any Regulations made thereunder, with the appropriate Model Code of Principals of Construction and Licensing Conditions issued by the Home Office under the Petroleum (Consolidation) Act 1928 and with the requirements of the Northern Ireland Fire Brigade and that the licence may at any time be cancelled if the premises cease to comply.

(4) I/We enclose a remittance of £ _____ being the amount of the licence fee.

- (i) an individual or partnership the full names and addresses of all partners;
- (ii) a limited company, the full name and address of the registered office in Northern Ireland of the company and the full name of the of the secretary or other authorised officer of the company must be given.

- (ii) a limited company, to be signed by the secretary or other authorised officer.

In the case of a new application or where any alterations have been carried out to the layout or storage, a map of the premises in duplicate on a scale not less than 1/2500 must be submitted with this form.
